16. To borrow money or receive money or deposit upon such terms, funds and assets of the Trust, as the Board of Trustees shall deem necessary or expedient for the objects of the Trust.
17. To invest the money of the Association not immediately required upon such securities or otherwise in such manner as may from time to time be determined.
18. The Trust shall be for the benefit of the institutions to be created by this Trust, and the institutions so created by this Trust shall be only beneficiaries.
19. To establish hostels, restaurants, eating joints etc. as essential for the purpose of attainments of the main objects.
20. Generally, to do all such other things as are deemed incidental or conducive to the attainment of all or any of the above objects.

5. MANAGEMENT & UTILISATION OF TRUST FUND:

- (a) The Managing Trustees shall stand the possessed of the said Trust fund upon Trust and also to receive any income or interest, dividends there of and voluntary contribution, donation and gifts and in the first place to reimburse themselves (other Trustee) or pay and discharge all the costs, charges and expenses incurred in or about incidental to the administration or execution of the Trust powers vested by these presents and also all outgoing taxes, rates assessments, dues, duties, levies and other taxes payable in respect thereof .and the cost of meeting of ordinary repairs to any immovable property if for the time being subject to the trusts of these presents and subject there to upon trust to apply the residue of the said interest, divided and other income and at their discretion to utilize the whole or any part of the corpus of the Trust fund for charitable services in India including (i) relief to the poor, (ii) promotion of education, culture, literature, art and science, and (iii) medical relief as per definition of "Charitable purposes in section 2(15) of the Income Tax Act, 1961 as the Trustees may think fit and in such manner as the Trustees may think and for one or more such public charitable purposes as aforesaid so as not to violate the provisions of Income Tax Act, 1961. Provided that the said income as well as the corpus of the Trust Fund shall be utilized only towards charitable purposes as aforesaid in India and any accumulation of income shall also be made and deemed to be made for application to such charitable purposes as aforesaid in India in accordance with the provisions of Income Tax Act, 1961.
- (b) Without prejudice to the generality of the foregoing objects or purposes but subject to the aforesaid, it is declared that the Managing Trustees shall each year utilize the income of the Trust and may at their discretion at any time and from time to time utilize the Trust Fund shall be solely utilized for furtherance of the objects of the Trust no part of it shall be distributed among the members of the Trust by way of profit or dividend or otherwise. The surplus and un applied portion of the said income, if any, arising in any

one or more year or years shall be accumulated and / or invested in accordance with the provisions of the income-Tax Act, 1961 as may be in force from time to time.

- (c) There shall be maintained all accounts of the Trust properly and regularly for every Financial Year commencing from 1st April to 31st March and the accounts shall be audited a Chartered Accountant every year.
- (d) That the unutilized balance in the hands of the Trustees in respect of the Trust Funds shall be invested in accordance the provisions of section 13(1)(d) read with section 11(5) of the Income Tax Act 1961.

6. GENERAL RULES & PRINCIPLE OF TRUST:

- (a) The number of the trustees including the managing trustee shall be not be less than three and the board may appoint any number of member trustees whenever thought in the interest of the trust.
- (b) Mrs Jyostna Moyee Nanda (Settlor) shall be the life trustees and unless they voluntarily resign or otherwise decide, shall continue to be the trustees during the term of their natural lives. In case of death, the nominated person by the outgoing trustee shall be the life trustee and the above provisions will apply to him/her also. In case of non-nomination, the legal heir (only one), shall automatically be the next life trustee of the trust and shall have the same power and duties as defined and the above provision shall be applicable for the successors also.
- (c) A life trustee may retire at any time without assigning any reason and without being responsible for any costs occasioned by such retirement.
- (d) 1/3rd number of trustees present in any meetings shall form the quorum of a meeting of the trustees.

- (e) The Settler of Trust of the Managing Trustee shall be the President of the board and in his absence the members present may select another member of the Managing Trustees to be the President of the board.

 - iii. of unsound mind; or
 - iv. A minor
 Shall be eligible to be a trustee.
- (h) A person shall cease to be a trustee in any of the following events:
 - i. If he dies; or
 - ii. If he becomes bankrupt; or
 - iii. If he becomes insane or otherwise become incapable to act; or
 - iv. If he resigns from his office; or

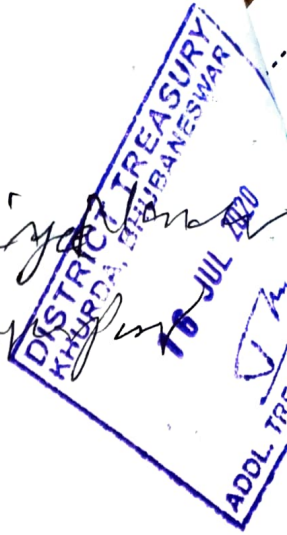

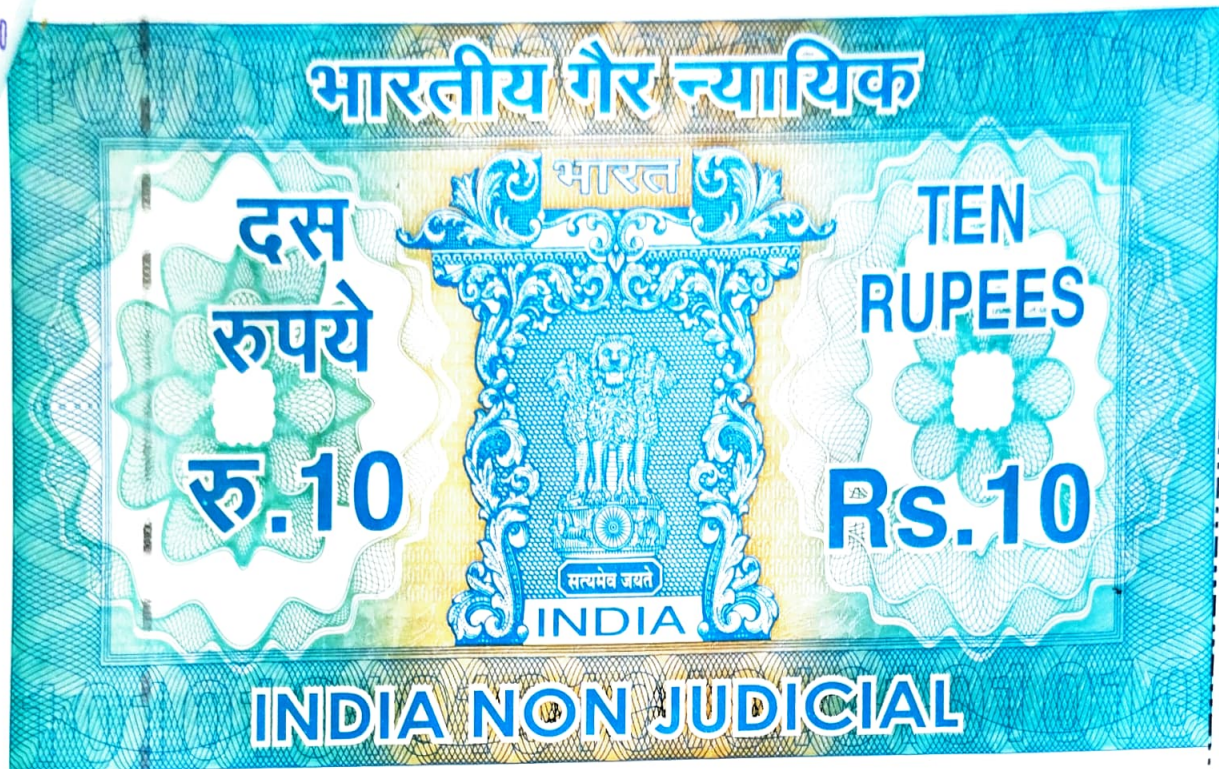

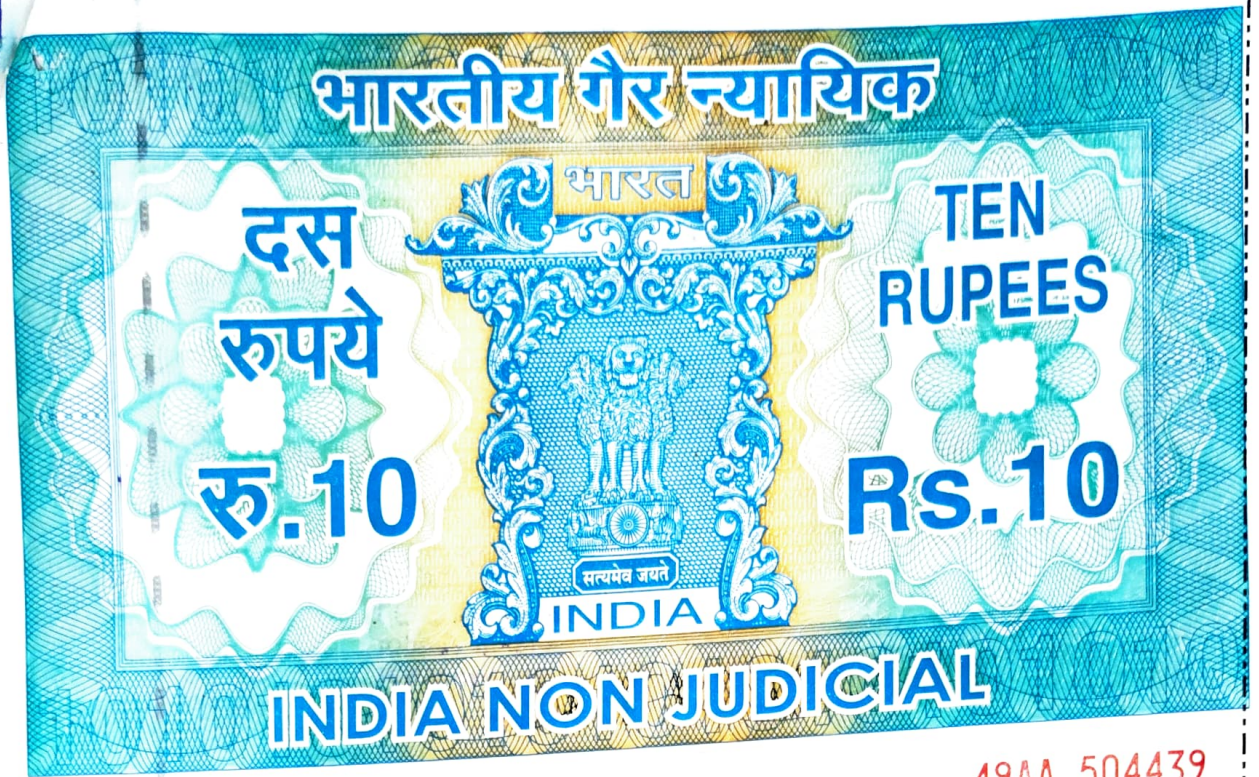
